The Child Advocacy Center (CAC) is a safe, child friendly location for families to come and speak with our trained interviewers and medical providers. Our Multidisciplinary Team consists of law enforcement, child protective services, prosecution, mental health, medical health, and victim advocacy. This specialized team works together on sexual abuse cases, the most severe physical abuse cases, and all child fatalities in Dutchess County. This year the Child Advocacy Center held its annual Multidisciplinary Team training to support the work of all our local agencies who work with this young population. Over 60 professionals attended the two day training from September 13-14 at the Dutchess County Department of Behavioral and Community Health to increase their knowledge on interviewing child victims with disabilities, internet safety, sex offenders and what they can teach us, cultural considerations of children you interview, and sex offender typologies. Although many of the attendees of this training were seasoned professionals, they found it
