## Virtual celebration set for WF St. Patrick's Parade

The annual, and beloved, Dutchess County St. Patrick's Parade through Wappingers Falls, as well as the Emerald Ball, has been canceled for 2021.

Sort of.

Ah, you didn't think a pandemic was going to hold down the will and determination of the Parade Committee, did you?

Instead, organizers have created a virtual celebration that will include just about everything other than the floats and the freezing weather.

The virtual celebration will take place on Saturday, March 6 and will start with the usual yearly Mass at St. Mary's Church in Wappingers Falls at 9 a.m.

"We consider ourselves very lucky that last year's 25th Anniversary took place," Committee Chairman Gene Noone said. "The Covid 19 virus caused all other parades in 2020 to be cancelled. This included New York City's world famous St.Patrick's Day Parade along Fifth Avenue.'

Since the Wappingers event attracts thousands of people every year, the Board of Directors and Committee members unanimously agreed that the safety of all involved is paramount.

But a good portion of what paradegoers would have seen can be watched on video. Starting on Monday, March 8, viewers can watch the virtual presentation at 2 p.m. and 8 p.m. on Fios Channel 35 and on Optimum Cablevision on Channel 22. It will run every day from March 8 to March 19.

## County COVID-19 update

## **Encouraging data** underscores vaccination urgency

At his Telephone Town Hall Forum on Feb. 24, Dutchess County Executive Marc Molinaro noted that COVID-19 data points - including active cases, hospitalizations and infection rate - are headed in the right direction after "a horrific January" resulting from a post-holiday surge.
To keep this desirable trend going,
Molinaro reminded residents to continue to follow all safety guidelines and reiterated the need for an expedit-

ed schedule of vaccine distribution.

The forum, as always, was also

streamed at the county's Facebook page (@DutchessCoGov).

If the questions and comments received during the forum are any indication, much of the public is eager to get a vaccine as quickly as possible but is extremely frustrated that even those who currently qualify for one have been mired down in the state's process for scheduling appointments.

In addition, the list of those currently eligible to receive a vaccine expanded further last week; individuals with developmental disabilities were added to the list of those with comorbidities approved under Phase 1B of New York's program. This brings the county's eligible population to more than 100,000. Even with recently increased distribution, it is still likely to take months to vaccinate currently eligible individuals.

That scenario could change, though, if the state acts on Molinaro's request to designate the former JCPenney location in the Poughkeepsie Galleria as a massvaccination site for the Hudson Valley. Currently, the Westchester County Center in White Plains is the designated state site for the region.

Molinaro has said that Dutchess County has the ability to administer up to 5,000 vaccinations a week - around five times the number being administered now. The approval to run the 185,000-square-foot Poughkeepsie POD (point of dispensing) as a state site would not only speed up the entire process but would make it easier for those relying on public transportation to have improved access to vaccines.

Gov. Cuomo's office has informed the county that it is considering the request. No decision had been made as this paper went to press on Monday.

### **Decision to reopen** schools up to districts

A frequent concern week-in and week-out on Molinaro's town halls comes from parents eager to know when their children will be able to return to school. He said the county supports the return to in-person learning, but the decision is up to each

crowd and performer. I've heard of underground shows and such, but on my end, I've been respectful of the restrictions put in place," said Lundberg.

Lundberg said he became interested in photography as a child.

"As a young person I was fortunate to have traveled during school vacations to the likes of Mexico and the Caribbean, my folks always instilled the importance of travel at an early age, thus I loved snorkeling and was always bringing along those disposable underwater cameras. However, it wasn't until I made the move from Boston to Brooklyn a few years ago, I took a serious interest in the medium, where I picked up a decent camera and was off running around attempting to document this new environment," he explained.

Lundberg added, "However, no matter street, music, or fine art photography -- what keeps me continuing to explore the medium of photography is my keen interest in human nature, behavior and our unique position to explore ourselves and our relationships through visual communications."

Asked how living in Beacon has influenced his photography, Lundberg replied, "Hmm, an interesting question. I guess one aspect is that being in a [quieter] environment has allowed me to reflect on my processes and craft as a serious artisan. This has been supplemented by my being actively involved with a local fine art photography group named "The Fix," in which we meet (digitally) on a monthly basis to discuss current projects, opportunities and industry topics. I've learned so much from the group, knowledge that I've put back into my own craft and processes. And of course being in Beacon, I've made a bunch of landscape, natural scene, and spatial images since I'm surrounded or just a walk away from some interesting natural scenes.'

Asked if he had a favorite photo, Lundberg responded, "A hard question, prior to the pandemic there were so many in the likes of capturing [comedians and actors] Louie Anderson, Sindbad, The National to name a few! But one that comes close to the pandemic (only a few months prior), was an image made of local pop surrealist painter Ron English. This was when I was kicking off my idea for the "Uncontaminated" interview series, which initially I framed as a in

## Cuomo agrees to independent investigation of sexual abuse allegations

Facing bipartisan calls for an independent investigation into sexual abuse allegations against him, Gov. Andrew Cuomo on Monday granted NYS Attorney General Letitia James a referral to investigate the claims brought by two of his former aides.

Cuomo's officially initially announced the selection of former Federal Judge Barbara Jones to run the investigation. On Feb. 28, Beth Garvey, special counsel and senior advisor to Cuomo, updated the governor's stance.

"We had selected former Federal Judge Barbara Jones, with a stellar record for qualifications and integrity, but we want to avoid even the perception of a lack of independence or inference of politics," Garvey said. "Accordingly we have asked the Attorney General of New York State [Letitia James] and the Chief Judge of the Court of Appeals [Janet DiFiore] to jointly select an independent and qualified lawyer in private practice without political affiliation to conduct a thorough review of the matter and issue a public report." selected by the Attorney General and Chief Judge."

AG James rejected the notion that the governor's office should have anything to do with the process, echoing the sentiment of a number of Democratic lawmakers.

"To clarify, I do not accept the governor's proposal," James said. "The state's Executive Law clearly gives my office the

authority to investigate this matter once the governor provides a referral. While I have deep respect for Chief Judge DiFiore, I am the duly elected attorney general and it is my responsibility to carry out this task, per Executive Law. The governor must provide this referral so an independent investigation with subpoena power can be conducted."

Noting that "Allegations of sexual harassment should always be taken seriously," James emphasized the necessity of a "truly independent investigation to thoroughly review these troubling allegations against the governor..."

As per New York State law, this can only be accomplished through an official referral from the governor's office based and must

include subpoena power.

"I urge the governor to make this referral immediately," said James.

On Monday, March 1, Cuomo announced

he would grant James' request.

"We expect to receive a 63(8) referral with subpoena power to investigate allegations of

"We expect to receive a 63(8) referral with subpoena power to investigate allegations of sexual harassment against the governor, in line with our demands and New York state law," said James.

The referral would be made solely to the attorney general's office.

"This is not a responsibility we take lightly," James said. "We will hire a law firm, deputize them as attorneys of our office, and oversee a rigorous and independent investigation."

## County to host forum to discuss services for those with IDD

The Dutchess County Department of Behavioral & Community Health (DBCH) will hold a virtual public forum on Tuesday, March 9, from 5:30 to 7:30 p.m., to discuss services offered in Dutchess County for people with intellectual and developmental disabilities (IDD). The forum will be via Microsoft Teams, and those who wish to attend must register in advance on the County's website, www.dutchessny.gov .

All input received at the forum will help shape the County's 2022 Local Services Plan for Individuals with Intellectual and Developmental Disabilities. Families and caregivers are especially encouraged to attend this public forum.

DBCH Commissioner Dr. Anil Vaidian said, "We strongly encourage the public to participate in our forums as they offer an excellent opportunity to ask questions and relay concerns directly with the people who plan our services and can advocate for improvements. Like so many events nowadays, we must hold this event in a remote

manner, but we are committed to holding this event because we truly want this feedback. It will help us tremendously in understanding what services work well, learn more about the challenges people face, and address where there may be shortcomings."

In addition to offering time for public comments, the forum will feature several speakers from a variety of agencies who will provide updates on services for 2021 as well as answer any questions members of the public may have. Presentations include:

- Deputy Commissioner of Special Needs Toni-Marie Ciarfella, Ph.D. will provide an overview of county's Think Differently initiative and efforts to offer vaccination to individuals who are diagnosed with IDD;

- A review of eligibility requirements and the application process to receive benefits from New York State's Office of Persons with Developmental Disabilities (OPWDD) and how to self-direct services; and

- Dutchess County Public Transit representatives will discuss accessibility and

updates to services as related to COVID-19.

Dutchess County continues its commitment to "Think Differently" with a strong focus on providing needed services to individuals diagnosed with IDD during the COVID-19 pandemic. Including advocating for and ensuring vaccination for IDD individuals served by OPWDD as well as those who are not.



## Is increasing government necessary?

To the Editor:

The current media narrative strongly supports more government involvement in issues that supposedly require government issued solutions. Such increasing government involvement only makes things worse. That is why it is important to look at why the Founders of this country defined American Exceptionalism.

American Exceptionalism is the idea that the United States of America is unique among the nations of the world in that it was founded on the principles of individual liberty, private property rights, and equal justice for all. Because it is unique, the United States has a special role in the world and in human history.

America is a country uniquely founded upon a successful idea, rather than ethnicity, religion, borders, tribal identity, or other such traits.

The values of the United States' founding were always about aspirations, not claims of national perfection. Through freedom, this nation aspired to foster greatness among its people. As an honest look at American history shows, our founders and their successors succeeded admirably in creating a nation in which individual freedom set the stage for unprecedented levels of human accomplishment. Other nations began to adopt some of our principles, and they benefited accordingly.

Importantly, our founders understood that greatness and exceptionality come from the people, not the government, and government can foster goodness only by protecting individuals from aggression by others. As the nation's founders recognized was likely to occur, governments at all levels in the United States have made countless unwise and indecent decisions, imposing great injustices, such as chattel slavery, indentured servitude, mistreatment of native populations, forced segregation, suffrage limitations, cronyism, and the like. These were not the actions of free people, however, but of governments, which are always subject to corruption, just as our nation's founders and Constitution acknowledged and did their best to prepare for.

Unfortunately, beginning early in the twentieth century, many thinkers from other nations and within the United States began to characterize America and its traditional values as an impediment to progress and human thriving. That was the very opposite of the truth, but it made its way into the American psyche through a concerted effort by propogandists and progressive politicians and writers of the early twentieth century.

These progressives took what has always been less than perfect in the United States—our governments— and characterized governments' failings as the essence of American history. These polemicists ignored or denigrated the principles of the nation's founding, which were aspirations, not an expectation of perfection, as the latter is never to be fully achieved because of the limitations of human nature.

The principles on which the United States was founded still stand and are still noble. The idea of American exceptionalism is a tradition of which we should be proud. It points the way toward national greatness: the greatness of a people despite the imperfections and limitations of government

## Arlington Girls gain huge win over OLL

That the Arlington High School girls basketball team beat Our Lady of Lourdes on Saturday was not a surprise.

After all, the Admirals again have a very good team. They proved last year they can beat the Warriors, and they only lost by eight on OLL's homecourt barely 48 hours earlier.

The method, however, was startling.

Arlington held mighty Lourdes to just single digits in points in each of the last three quarters – 16 total – and rode its defense to a 42-29 victory Saturday.

Arlington and Lourdes are both 6-1 overall now.

"It was a quick turnaround from our game with them on Thursday. We made a few adjustments and the girls played very well on the defensive end," Admirals coach Kim Costello said. "To hold a team like Lourdes to 29 points takes a solid effort from all five girls on the court. I'm very proud of how the girls bounced back


and how they played with a lot of energy today. This was a big win for us."

Lourdes could never get untracked. After taking a 13-12 lead after the first quarter on the strength of nine points from Purdue University-bound Ava Learn, the Warriors struggled the rest of the way. The Admirals held Lourdes to five, seven and four points, respectively, in the final three quarters. Learn finished with 16 points.

Arlington had an extraordinarily balanced offensive effort. Jenna Weinstein had nine points and six rebounds for the Admirals while Mia Castillo had eight points, eight boards and three steals.

Alexa Hurley had eight points, six rebounds and three assists, and Bella Kostyal continued to give Arlington big minutes off the bench with eight points and seven rebounds.

Ava Allen played limited minutes with foul trouble but still managed to pull down 11 rebounds and had three steals.

Maya Watts was also strong inside with six rebounds and two blocked shots.

"This was a team win," Costello said. So, coach, how did you do it? Costello will never tell.

"Well, I don't want to give away too many secrets since we very well might see them again in the playoffs," Costell said with a laugh. "Coach Zmudosky and I watched our Thursday's game film that night and just tried to see where we could improve. We switched our positioning a

school district.

A new data point on the county's COVID-19 Dashboard displays the infection rate per 100,000 people, which is a good indication of the transmission rate in a given area. Updated CDC guidance suggests that communities with low-to-moderate transmission rates should be able to reopen K-12 schools with safety protocols in place.

Dr. Anil Vaidian, commissioner of Dutchess County's Department of Behavioral and Community Health (DBCH) joined Molinaro on the Feb. 24 call.

"We have been monitoring disease activity in the community, looking at

where people are getting COVID and what are the points of transmission," said Dr. Vaidian. "We don't find that the school setting, especial K-8, is at high risk of transmitting COVID."

He added, "I think it's reasonable for school districts to entertain, or decide, bringing more children into [in-person learning]."

### IN BRIEF:

- Reminder: Senior citizens without online access to schedule a vaccination appointment can dial (845) 486-3555; press 1 to hear an update, and then press 2 to be connected to an Office for the Aging representative (during regular hours), who will input your information into the system. If you call after hours, leave a message.

- To sign up for a waiting list for a vaccination appointment at a county-run site, visit dutchessny.gov/vaccineinfoform; fill out the form, and every week, when the county gets vaccines, an IT application will randomly pick names from the list of eligible individuals, who will be advised that an appointment is available.

- Currently, vaccines are not available for homebound seniors. As the county receives more doses, officials expect to have more pop-up clinics to facilitate this process.

- Dr. Vaidian answered questions about the newly approved Johnson & Johnson vaccine. "When you have a vaccine that's 66-percent effective, we call that a really effective vaccine," he said. "It's a different technology [from the Pfizer and Moderna vaccines, which are about 95-percent effective after the second dose], but it's very highly effective. It depends on population, severity of illness and strain, but it ranges to about 70-percent effectiveness."

- Asked why it's necessary to wear a face-mask and follow other mitigation guidance after being vaccinated, Dr. Vaidian said it would still be possible to get the virus even though the body would fight off the infection. "We may get the virus in our nose or other entry [and] we could potentially give it to others."

## Fishkill board hears from Dutchess County Human Rights Association

## Deputy sheriffs receive 'lifesaving training and equipment'

Dutchess County Sheriff Adrian "Butch" Anderson announced that Deputy Sheriffs received Tactical Emergency Casualty Care training and bleeding control kits through a partnership with two organizations.

Anderson said, "We thank Guardian Revival and Medicine in Bad Places for providing us with lifesaving training and equipment. Often times, Deputy Sheriffs are the first emergency responders on the scene of violent crimes, motor vehicle crashes or other incidents where bleeding control measures need to be implemented to save a life. With the help of our friends from Guardian Revival and Medicine in Bad Places, deputy sheriffs are now better equipped to take necessary, lifesaving actions when faced with a medical trauma situation."

Medicine in Bad Places partnered with Guardian Revival to provide lifesaving equipment and training to Dutchess County Deputy Sheriffs. Over the course of two days, Medicine in Bad Places instructors taught a Tactical Emergency Casualty Care Course to approximately 120 Deputy Sheriffs and outfitted them with custom individual first aid kits.

This training will allow Dutchess County Deputy Sheriffs the ability to effectively respond to any medical trauma emergency, mass casualty incident, or active shooter situation they could be faced with. The custom medical kit aht each Sheriff Deputy received contains a tourniquet, compression bandage, QuikClot Bleeding Control Gauze, Nasal airway, and chest seals. Medicine in Bad Places also warranties their kit and will replace any item used in the line of duty by first responders, ensuring that officers will always have the gear they need.

In recent years, the U.S. has seen an increase in the number of large-scale incidents involving penetrating trauma or blast injuries, such as active shooter incidents. The provision of tourniquets and other trauma-stabilizing equipment to law enforcement officers can allow for the rapid triage and treatment of individuals, including other officers, at risk of death from severe hemorrhage.

For example, the events of the Boston Marathon bombing highlight the potential benefit of equipping law enforcement with tourniquets. During that incident, it was identified that the rapid application of a tourniquet resulted in multiple individuals surviving who might otherwise have died from exsanguinating hemorrhage.

While emphasis has been placed on response to motor vehicle accidents and violent crime, deputy sheriffs are often first on the scene during adverse weather events, agricultural or industrial accidents and other unique hazards. The core concepts are no different: responding Deputies should be able to assess the scene for threats and manage them once found. In addition to providing medical care to injured members of their communities, law enforcement officers may find themselves providing care to colleagues, either during periods of active threat when conventional EMS cannot enter the scene due to safety concerns or prior to the arrival of EMS.

"After three years of hard work to make this dream a reality, we are excited to finally have Peace home," said Kim Haight, CPCA executive director. "We know from previous experience, that the presence of a service dog is extremely helpful in putting a child at ease. The children we work with have been through some of the most devastating experiences and having Peace here to provide the support they need at a moment's notice is such an asset."

A 2018 study published by the National Institute of Health found that children participating in a forensic interview following allegations of child abuse while accompanied by a service dog exhibited a significant decrease in heart rate, blood pressure, and other indicators of stress when compared to children interviewing without a service dog present.

term limits, will provide continued transparency and best serve the residents of
Dutchess County. The commission will proceed free from political influence or legislative authority to ensure a fair unbiased repre-

## PSC approves major transmission line project from Rensselaer to Dutchess

Governor Andrew Cuomo recently announced that the New York State Public Service Commission (PSC) approved the New York Energy Solution Project - a 54.5-mile, 345-kilovolt transmission line valued at an estimated \$530 million starting in Rensselaer County and extending to Dutchess County to speed the flow of clean, reliable energy to high-demand markets and consumers downstate.

The PSC also granted NextEra Energy Transmission New York Inc. the necessary approvals to exercise municipal agreements to construct the Empire State Line - a 20-mile, 345-kilovolt electric transmission line, located in Niagara and Erie counties and valued at an estimated \$180 million, that will help relieve congestion and maximize the flow of renewable resources in Western New York.

These approvals are the final set of major approvals required to commence construction on the 250 miles of the green energy transmission superhighway this year, as announced in Cuomo's 2021 State of the State address.

These initiatives increase transmission capacity to move power more efficiently in keeping with the goals of both the Climate Leadership and Community Protection Act (CLCPA) and the Accelerated Renewable Energy Growth and Community Benefit Act to lower carbon emissions and combat climate change. These projects are also expected to stimulate the local and regional economy by increasing employment and earnings in the construction industry.

New York is leading the nation in developing a green economy with key investments to enhance the reliability and resiliency of the state's energy infrastructure," Cuomo said. "These projects are essential to helping create our new green energy superhighway that will move electricity to high demand areas efficiently while also reducing costs and helping to create new jobs."

In addition to approving the New York Energy Solution Project and the Empire State Line, the PSC also took two other notable transmission actions, including:

- Approved the environmental management and construction plan filed by LS Power Grid New York, LLC, LS Power Grid New York Corporation I, and the New York Power Authority, to construct and operate Segment II of the 93- mile transmission project known as the Marcy to New Scotland Transmission Upgrade Project. The overall project was approved by the Commission on Jan. 21; and

- Approved a fast-track for certain local transmission and distribution projects, known as Phase 1 projects. Phase 1 projects are actionable projects that satisfy traditional reliability, safety and compliance purposes but can also be accelerated or reprioritized to address bottlenecks or constraints that limit the delivery of renewable energy within a utility's system. The steps establish the process for cost recovery and allocation for such projects. The Accelerated Renewable Energy Growth and Community Benefit Act requires the PSC to, among other things, reorient transmission planning and investment toward the achievement of CLCPA

Additionally, the three transmission project actions for New York Energy Solution Project, Empire State Line and the Marcy to New Scotland Transmission Upgrade Project build off of the prior approval of the New York Power Authority's Moses-Adirondack Smart Path Reliability Project - a vital 86-mile stretch of New York's North-South power transmission system and the fourth project within the 250 miles of transmission projects in construction this year. These new lines also will be complemented by the Northern New York Priority Transmission Project, a more than 100-mile new transmission upgrade project at the top of the state that includes the rebuild of existing transmission lines and expansion of several substations, enabling existing wind and solar resources from the North Country region to be added to the grid and allowing for new renewable energy projects to be connected in the future.

The New York Energy Solution Project transmission project, owned by New York Transco, will alleviate electricity bottlenecks that currently exist and allow for greater use of clean energy produced upstate, while also improving grid

resiliency and storm hardening. It will upgrade and replace existing 80-year-old structures with about 230 fewer, more modern structures. The project will be in existing electric transmission corridors or on adjacent utility-owned land in the Town of Schodack in Rensselaer County; thetTowns of Stuyvesant, Stockport, Ghent, Claverack, Livingston, Gallatin and Clermont in Columbia County; and the towns of Milan, Clinton and Pleasant Valley in Dutchess County.

The Empire State Line will help relieve congestion and maximize the flow of renewable resources in Western New York, including hydroelectric power from the New York Power Authority's Niagara Power Project, and from electricity imports from Ontario. The transmission project will involve construction of the transmission line and associated switchvards in the Town of Royalton in Niagara County and the Towns of Alden. Newstead, Lancaster and Elma in Erie

New York Transco will work with Orange and Rockland Utilities Inc. and Central Hudson Gas & Electric Corporation to develop additional, related infrastructure upgrades previously required by the PSC. The International Brotherhood of Electrical Workers supports the project because it will create many well-paying construction jobs for New Yorkers. The project will be operational by the end of 2023.

## **Parsnips**

## If you haven't tried this humble root vegetable, what are you waiting for?

In the food world there are some things that just don't get their due, foods that never quite make the trendy list or are just sadly overlooked and underappreciated. I get that not everyone gives Lima beans much love, for example, but don't worry; this isn't about them. Maybe we'll save that for another day since it will likely take a lot of convincing. Today I'm talking about something most will find much more palatable, something you may not give a second thought to and walk right by in the produce section. I mean to change your mind about the humble parsnip.

Parsnips may look like pale, bulbous carrots, and they are related, but in my opinion this association is deceiving. Their complex flavor is at once sweet, rich, earthy, nutty and even slightly peppery. Their versatility is another big plus as they can be mashed, roasted, braised, steamed, sauteed or pureed. Sliced into ribbons they can be a substitute for pasta, sliced into rounds they add a lot to gratins and when boiled and mashed they add rich complexity to mashed potatoes. They pair beautifully with everything from ginger and maple syrup to apples, onions and fennel. They're also really good for you: They're low in carbs, high in fiber and loaded with folate, vitamins C and K, potassium and antioxidants. With all that going for them and more, what's not to love?

I first fell in love with parsnips about

15 years ago while staying at a friend's farmhouse one early March to help collect sap for their maple syrup. We'd been out in the cold, snowy woods all day, going from tree to tree, pouring the sap buckets into a container we then emptied into a huge vat at their sugar shack. The sweet steam that filled the shack made for a comforting sauna as the sap boiled, staving off the chill before we headed back out to collect more. It was hard work, but interesting and fun - a real learning experience for

After such a long day, a hot shower and a hot meal were most welcome and as we were about to sit down to dinner, our host brought one last dish to the table, his pride and joy. He had a secret stash of parsnips, still in the ground under a cold frame, that he harvested moments before, boiled in milk and brought to the table piping hot. Keeping them in the ground all winter concentrated the sugars, making them delectably sweet. It's all I remember from that meal and I regret that I didn't get his recipe. They were, quite simply, amazing.

After that, parsnips certainly had my attention. I would never again walk past them without remembering that experience and being more than tempted to bring some home. Recently I've been craving them, so it seemed only right to share. I hope I can convert a few of you

into lovers of them, as well.

Certainly eating them fresh out of the ground is preferable, but don't for a minute think the ones you'll find in stores aren't worth buying. I suggest selecting those small to medium in size. Larger ones will tend to be woody in texture, less sweet and may need to be cored, which is more work than you need to do. They'd be fine for soup, especially if pureed and used as a thickener, but for the recipes here, go with smaller ones.

You'll want to trim off the top and bottom before using. If they're on the larger side, you may also want to peel them as you would carrots, but it isn't necessary as long as you give 'em a good scrub. That way you retain more of the nutrients. One more thing to know: Parsnips are best used as soon as they are cut or peeled. If left to sit they will brown when exposed to air. If you want to prep them ahead of time, just put them in a pot of cold water and drain before use.

So now, let's get cooking!

## **ROASTED PARSNIPS**

This is one of the easiest ways to enjoy them at their best, caramelizing the natural sugars. To make them better than best, parboil them first to soften the starch and prevent dry or chewy results. Just be sure to pat them dry before popping in the oven or they will steam, not roast into caramelized perfection.

NOTE: Instead of oil, you can toss parsnips in melted butter or maple syrup. Feel free to toss in garlic, minced ginger, cinnamon, red pepper flakes or herbs (parsley, thyme and oregano are good choices).

## **INGREDIENTS:**

2lbs fresh parsnips, cut into quarters, 2" pieces or batons

Olive oil

Salt and freshly ground pepper to taste Fresh rosemary, minced (~1 teaspoon)

**METHOD:** 

Preheat oven to 425 degrees. To parboil, place cut parsnips in boiling water and cook 8 minutes or until just tender. Drain, rinse with cold water until no longer steaming and pat dry.

Place parsnips in a large bowl. Add seasonings and drizzle with olive oil, tossing until evenly coated, adding more oil

Spread parsnips evenly in a single layer on a baking sheet - you may need 2 baking sheets so as not to overcrowd - and roast until golden brown and tender, 20-30 minutes, tossing halfway through.

Serve with pork, chicken, beef, lamb or salmon. Makes 4 servings.

What's something different to serve with dinner that's less starchy than potatoes, sweeter than carrots, incredibly versatile, goes with just about everything and easy to prepare? Hmmm ... let me think. Well, if I haven't sold you by now, consider bringing home some parsnips anyway and find out for yourself. Boil and mash some with potatoes, with or without a little horseradish, saute some with bacon or simmer in milk. You could even add them to cake, but that's a recipe, perhaps, for another day. My point is, instead of ignoring them, seek them out and see what you can come up with. If you do you'll wonder why you waited so long. Enjoy!

## 'D' is for Dominica

Adventure, beaches, hiking, exploring - small island has it all!

The Commonwealth of Dominica has long been on my list of islands to visit. More commonly and simply known as Dominica, it is correctly pronounced as Doe-min-

The strong commitment to both nature and the environment has earned it the nickname of "Nature Isle of the Caribbean." According to the island's website, it has been given this moniker due to its abundance of natural resources that include lush rainforests, ongoing volcanic activity, healthy marine life, unrivaled bird species, caves to explore, boiling lakes and non-boiling lakes.

The tiny island flies under most people's radars likely due to lack of publicity and/or the lack of non-stop flights. It also struggles with its identity as many mistakenly believe that it is the same island as the Dominican Republic, the subject of next week's article. The names may sound alike but they are not

Indeed, the two islands couldn't be more different from one another. Dominica is considered to be part of the Lesser Antilles, and, in fact, as the youngest island in the Caribbean chain, it is still being formed by geothermal volcanic activity. Dominica lies between two major bodies of water. To its West side, you have the Caribbean Sea with its calmer waves, gently lapping the shores of softer beaches. To its Eastside, you have the Atlantic Ocean, with stronger waves, perfect for surfing, and its slightly coarser sand.

Both sides offer multiple beaches from which to choose. In between the two areas you have lush mountains that are perfect for hiking and exploring. Other features of this very unique island include the world's second-largest hot spring called Boiling Lake.

Be mindful that the name is not just a clever lure to entice tourists. The lake water temperatures average 180 to 197 degrees Fahrenheit. It is possible that you could sustain some serious burns if careless. Further, you really have to want to visit the Boiling Lake as the time and distance over rough terrain can be a strong deterrent.

But oh, what a once-in-a-lifetime experi-

ence it would be! Visit dominicaadventures.com/boiling-lake.

The island also has lush mountainous, rainforests, and is a natural sanctuary to many rare plants, animals, and bird species. You can also find dry and arid areas on the west coast where little rain falls, but inland you can often experience heavy rainfall.

It is an island of contrasts and a paradise for birdwatchers! The microclimates support a variety of wildlife such as the sisserou parrot, a gorgeous, multi-colored bird that is also known as the imperial amazon bird and found only on Dominica. If you'd like to see what this unique creature looks like here's link en.wikipedia.org/wiki/imperial\_ama-

Indeed, it is one of 79 types of birds that make this island their home. You will also find an abundance of mammals, two of which I've not heard of - the Agouti and the

The Agouti is named for its coat pattern, which indicates that each strand of fur has multiple stripes of different colors and is considered to be a cousin to the opossum family. The Manicou is also nocturnal and is a "cousin" of the kangaroo, carrying its young in her pouch. It is an omnivore consuming fruits, small animals, and carrion.

While Dominica's position in the Caribbean Sea offers many unique experiences, you might not find on other islands, it also puts this little gem in, what is referred to as, "the Hurricane belt."

Dealt a trifecta of disasters from Hurricane Erika in 2015, and both Hurricane Irma and Hurricane Maria in 2017, the little island was left with 90 percent of the its infrastructure devastated.

I was heartened to learn that they had some unexpected supporters in their recovery process. According to a press release: Last year, Meghan Markle and Prince Harry's Archewell Foundation announced a new partnership with World Central Kitchen, a non-profit founded by chef Jose Andres that helps feed communities worldwide. The former Prince and Duchess pledged to fund

four "Community Relief Centers," the first of which was completed in Dominica, and I say "well done."

Still, the country needs to find a healthy balance between tourism and the preservation of natural resources. Tourism will provide jobs and boost the economy, and that's a good thing. Too many visitors would likely harm the environment in many ways, thus making it less unique, and more like every other overpopulated tourist destination. My hope is that they will be able to find a way to manage the balance that allows both human and animal residents to benefit from tourism and preservation.

Next week we'll revisit "D" as we explore the Dominican Republic.

Join us for a free virtual event by the Alzheimer's Association exploring the impact of dementia on communities of color.


